Statement on the Directive 2011/65/EU (RoHS)

Dear Sir or Madam,

We hereby confirm that – apart from mutually agreed exceptions and some versions of specific reed relays, reed switches or relays with cadmium-containing contacts – we will only supply you with RoHS-compliant products. The RoHS-Conformity will be noted by agreement on our order confirmation, invoice and delivery note.

If for any technical or scheduling reasons we are unable to supply you with RoHS compliant components we would inform you before accepting the order. Only if you have accepted explicitly to be supplied with non-RoHS compliant components, we will perform with the purchase order and delivery.

We would like to point out expressly that it is the customer's responsibility to pay attention to the possible exceptions and their validity - such as the use of relays with cadmium-containing contacts. We particularly ask you to observe the delegated directives (EU) 2018/742 and (EU) 2019/171.
