Statement on the Regulation (EC) No 1907/2006 (REACH)

Dear Sir or Madam,

REACH (Registration, Evaluation, Authorization and Restriction of Chemicals) is a regulation of the European Union. Above all, this regulation aims to protect human health and the environment from the risks that could arise from chemicals. We have familiarized ourselves with this regulation in order to be able to supply them compliantly.

All products manufactured and sold by ZETTLER electronics GmbH fall under the definition of articles in Article 3, No. 3 of the REACH Regulation.

Registration of our products and imported articles is not required to the best of our knowledge, as it does not release any substances in quantities greater than one ton per year that require normal or reasonably foreseeable use.

Except for electromechanical relays with cadmium-containing contacts, specific reed relays and reed switches, to the best of our knowledge, our products do not contain any of the substances listed in the SVHC list (Candidate List of Substances of Very High Concern for Authorization) in concentrations above 0.1% by mass. Relays with cadmium containing contacts and other SVHC containing products are specially selected by our customers.

We fulfill our obligation to provide information in accordance with Art. 33 of the REACH Regulation, i.a. with the information in the data sheet. The contact pills of a cadmium containing relay contain SVHC above 0.1% w/w – cadmium oxide: CAS-Nr.: 1306-19-0, EG-Nr.: 215-146-2.

Relays with cadmium-containing contacts, which are intended to be placed on the market after January 5th, 2021, have been registered in the SCIP database. The list refers to the status of December 22nd, 2020 and can be expanded or changed at any time.

Alloy of the contact rivet: AgCdO (Silver-Cadmium-Oxide), see information in the respective data sheet.
SVHC above 0,1 % w/w in the contact rivet: Cadmium oxide. Concentration: approx. 10% of the AgCdO alloy.
